b) Application for a 4th exam attempt appendix 24-138

The Study Board grants an exemption for a 4th exam attempt on the grounds that the student discovered late in his/her studies that he/she is dyslexic.

- c) Application for study inactivity appendix 24-139
 - The Study Board grants an exemption based on the student's documented illness.
- d) Application for extra time for exams in January 2025 appendix 24-140

 The Study Board rejects the application because the student justifies his/her application with a condition that may change before the exams in January. The student has the opportunity to apply for an exemption again with new documentation closer to the exam if the unusual circumstances still apply.
- e) Application to take the project exam alone appendix 24-141
 - The Study Board grants an exemption to be examined individually in connection with the group exam. This means that the student participates in the presentation with the group and can be examined individually.
 - The Study Board grants an exemption based on the student's documentation.
- f) Application for 50% extra time and aids appendix 24-142
 - The Study Board grants an exemption for 100% extra preparation time for oral exams with preparation.
 - The Study Board considers that 25% extra time for written exams is sufficient. The student has also applied for extra time for oral exams here the Study Board considers that the examiner and censor can, for example, ask questions in a different way, and therefore there is no need for extra time.
 - The student has the opportunity to apply for aids through SPS.
 - The Study Board grants an exemption based on the student's documentation.
- g) Application for extra preparation time before oral exams appendix 24-143

 The Study Board grants an exemption for 100% extra preparation time for oral exams with preparation.
 - The Study Board grants an exemption based on the student's documentation.
- h) Application to use a dictionary during written exams
 - The Study Board grants the student an exemption to use Google Translate or alternatively the Translate function in Word during written exams, due to dyslexia. The student is not allowed to use physical dictionaries.

The Study Board decided that the Data Science exam will only be held in April for all students (both Bachelor's and Diploma) and not in June.



Additionally, a date needs to be found for the oral exam for Bachelors of engineering under the old curriculum in Carbohydrate Chemistry in April.

Several other changes were also proposed – Sara will create an updated exam schedule, which will be sent for approval by the course holders. LHP will talk to the Protein Structure instructor regarding the exam format and date.

The exam schedule for August 2025 was discussed, and some dates will be moved. Sara will create an updated version of the re-exam schedule.
