# 7. Evaluation of Study Activities (ESA reports from AAL and CPH), Spring 2022

Due to the upgrade of the AAU quality system last year the report name has changed to "Evaluation of Study Activities" (ESA). CBM mentions that it would be great, if we could have a better survey for the students.

#### CPH:

MED2C Response rate: 31/60.

- MSN is going to actively push for a modernization of the survey to achieve much higher response rates
- MSN is concerned with the low self-reported weekly workload
- MSN encourages AAL and CPH teachers of the Programmering af Mobile Applikationer course to connect and work on joint development of the course.

## MED4C Response rate: 13/47.

- MSN is going to actively push for a modernization of the survey to achieve much higher response rates
- MSN is concerned with the EXTREME low self-reported weekly workload
- MSN is concerned with the problems regarding getting students to physically participate in the semester to create a sound study environment
- MSN is concerned with the overall evaluation of the semester
- MSN notices that the students struggled to keep up with the material in the Audio Processing course, a problem most of the theory-heavy courses face

#### MED6C Response rate: 8/34.

- MSN is going to actively push for a modernization of the survey to achieve much higher response rates
- MSN is concerned with the low self-reported weekly workload
- MSN is highly surprised by the grade statistics for the project module; not at least as the grades for the same semester in AAL were significantly lower. Some cross-campus comparisons could be very interesting
- The Programming Artificial Intelligence course did not get good review by the responding students; hopefully in a future version can be easier for students to digest the studied material

## MED8C Response rate: 5/44.

- MSN is going to actively push for a modernization of the survey to achieve much higher response rates
- MSN is concerned with the low self-reported weekly workload



#### SMC8 Response rate: 3/14.

- MSN is going to actively push for a modernization of the survey to achieve much higher response rates
- MSN is extremely concerned with 7/13 not qualifying for participation in the ordinary exam in Physical Models for Sounds Synthesis. And 11/13 not for the Sound and Music Signal Analysis course. It should not be a viable strategy for students to "buy more time" by forfeiting the ordinary exam

#### SSD8 Response rate: 6/36.

- MSN is going to actively push for a modernization of the survey to achieve much higher response rates
- MSN is concerned with the low self-reported weekly workload
- The poor evaluation of the PBL course appears to be a general thing across all 8th semesters. MSN will follow up

LID8 ESA report is missing due to illness.

#### AAL:

#### MED2A Response rate: 12/29.

- MSN is going to actively push for a modernization of the survey to achieve much higher response rates
- MSN is concerned with the low self-reported weekly workload
- MSN is pleased with noting that student group project prototypes were judged to be of good quality; hopefully the new study plan and introduction to digital development on MED1 has something to do with that
- MSN encourages AAL and CPH teachers of the Programmering af Mobile Applikationer course to connect and work on joint development of the course

#### MED4A Response rate: 12/17.

- MSN is going to actively push for a modernization of the survey to achieve much higher response rates
- MSN is concerned with the low self-reported weekly workload
- MSN is pleased to note that the group forming process was given some constraints (at least 1 new member); group forming is a focus area for the Medialogy studies going forward
- MSN encourages the semester team to give joint supervision another go next year,obviously in an updated form. The idea definitely has potential
- The semester will according to a new study plan in spring 2023

# MED6A Response rate: 17/33.

- MSN is going to actively push for a modernization of the survey to achieve much higher response rates
- MSN notices the relatively low grades in the project module. In particular, it is
  interesting to note that the same semester in CPH had extremely high grades. Would be
  interesting if some sort of explanation could be hypothesized. Some cross-campus
  comparisons could be interesting



#### MED8A Response rate: 6/29.

- MSN is going to actively push for a modernization of the survey to achieve much higher response rates
- MSN is concerned with extremely poor student performance at the ordinary exam in the Algorithms, Data Structures and Software Engineering course
- MSN will follow up on apparent overlap between Embodied Interaction and Machine Learning
